- 4. Learners will discuss the contrast between Multidisciplinary, Interdisciplinary, and Interprofessional/Transdisciplinary approaches to pain care.

- 5. Learners will discuss how diet can directly impact chronic pain.
- 6. Learners will discuss and demonstrate multimodal approaches to pain management employing a variety of techniques and treatments that military healthcare is dedicated to embedding into all MTFs.
- 7. Learners will describe the role of glutamate in chronic pain and its common comorbid symptoms.
- 8. Learners will recognize the role of central sensitization in chronic pain and its relationship with the neurotoxic triad.
